We thank you for your letter of the 25th July confirming your cable of the same date. "World Sky" arrived on the 28th ultimo, and Lt/Commander R.J. Cole was appointed by us to survey the damage with a view to extending the seaworthiness certificate for the ballast voyage to Khorramshahr.

We would take this opportunity of acknowledging your cable of the 28th ultimo requesting re-examination of the repairs to "World Sky's" bow. When this arrived Lt/Commander Cole had already decided that additional cement should be applied before a seaworthiness certificate could be granted, as reported in our cable of the 28th. This was eventually completed to his satisfaction and the vessel sailed on the 30th ultimo for Khorramshahr.

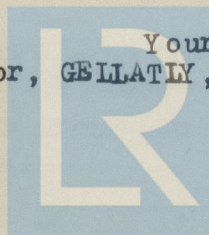
We enclose a copy of the survey report and certificate of seaworthiness, and confirm that our charges for same will be collected locally.
