

SINGLE AND TWIN ONES

Cables: Single, twin, concentric, or multicore are the cables insulated and protected as per Tables IV or V of the Rules **YES**
 Fall of Pressure, state maximum between bus bars and any point of the installation under maximum load **2V + 3% PER CENT FOR LIGHTING**
2V + 15% FOR POWER

Cable Sockets and other connections, are the ends of all cables having a sectional area of 0.04 square inch and above provided with soldering sockets **YES**

Paper Insulated Cables, If cables are paper covered, is the dielectric at the exposed ends of the conductor protected from moisture by being suitably sealed with insulating compound

Cable Runs, are the cables fixed as far as possible in accessible positions not exposed to drip or accumulation of water or oil, or to high temperature from boilers, steam pipes, uptakes or other hot objects, or to avoidable risk of mechanical damage **YES**

Support and Protection of Cables, state how the cables are supported and protected **SUPPORTED BY METAL CLIPS. ALL POWER CABLES LEAD COVERED AND ARMOURD. LIGHTING CABLES LEAD COVERED IN CABINS. FOR THE REST LEAD COVERED AND STEEL WIRE PLAITED OR ARMOURD**
