I have surveyed the above ship in accordance with the Rules for Commencement of Special Survey &amp; Docking Survey.

The items now surveyed are detailed on this report. All were found or placed in good condition unless otherwise stated.

Wear & Tear Repairs

F.P.space, lower end of frames (p & s) wasted, now cropped and renewed;  
F.P.hatch opening, wasted ends of beams and girders (p & s) now cropped and renewed.

No.1 hold, centre line longitudinal bulkhead between hatches. Nos.1 & 2 and after one, wasted at bottom, now cropped and renewed for about 2 ft. from tank top.

No.2 hold, two brackets bent, now faired.

E.R.sounding pipes fitted with self closing cocks.

Side scuttles broken glasses renewed and 4 missing deadlight fitted.

F.P.space hand pump repaired as necessary.

Air pipes provided with wood plugs as necessary.

F.P.space hatch on forecastle deck, rubber joints renewed.

I recommend that this ship remain as classed with ~~XXXX~~ fresh record of dry docking 4,65 and to have the notation of SS 5,65 when the survey has been completed, without condition of class regarding indented shell plating (p.s.) and indented stem plating in way 13 ft draught mark being specially examined and dealt with as necessary and 15 fms of chain cable and bower anchor being supplied but subject to 90 fms of chain cable (No.4 & 5 s.s. & Nos. 4 to 7 p.s.) being renewed at earliest opportunity.

- 1) Indented shell plating (p.s.). Indented stem plating in way 13 ft draught mark to be specially examined and dealt with as necessary.— These indents were now examined, found to be of minor importance and as no repairs were carried out, it is submitted that they may be noted in the SRL Appendix.
- 2) 45 fms chain cable to be verified.— This item was dealt with previously according to Interim Certificate of Turku of 2.12.1963.
- 3) 15 fms of chain cable to be supplied.— From records shown it was noted that previously the vessel was equipped with 255 fms total of cable i.e. 15 fms in excess of Rule; therefore the supply of these 15 fms does not affect the class.
- 4) Bower anchor to be supplied.— The bower anchor lost in Ceuta was recovered and refitted on board.

It is submitted that all the above conditions of class may be deleted from against the ship's class.

New condition of class

75 fms of chain cable i.e. Nos.4 & 5 (s.s.) and Nos.4,5,6,7 (p.s.) found 40-42 mm mean diameter and recommended their renewal; as the Owners claimed that these cables could not now be renewed it is submitted that a condition be inserted against the vessel's class stating that they should be renewed at earliest opportunity.

To complete the Special Survey

The outstanding condition of class remains to be dealt with.
