
Apparently, Attorneys have been in touch with your local representative, Mr. Crawford, and they write as follows:-

" Mr. Crawford suggested that the plan of the ship's profile and decks as well as the copies of the Class Report for surveys held at Hamburg and Karachi etc. may be obtained from the Secretary, Lloyd's Register of Shipping, 71, Fenchurch Street, London, E.C.3. Under the circumstances, I think it would be proper for us to write to our London Office for the following particulars of the vessel "Phoenecian Star" 4925 gross tons of Panama:-

- (1) Plan of ship's profile and decks.
- (2) Copy of detailed Class Reports for surveys held at Hamburg in October 1965.
- (3) Copy of detailed Class Report for surveys held at Karachi in October 1966.
- (4) Copy of Class Report for surveys, if any, held at Chittagong in November or December 1966 or thereafter.
- (5) Whether the vessel "Phoenecian Star" is still at sea or if broken up, where and when.
- (6) Any other information regarding the vessel which may help us in establishing the unseaworthiness of the vessel."

We accordingly enquire as to whether you are able to supply all or any of the desired information and look forward to your valued advices in this regard at your early convenience.
