(with date) when the survey has been completed, without special condition to shell plates SB, 9, 18, 19 (SSa), F6, 67 (PSa), H & I strakes in way of Fns.60(PS), 71/73 (SS) and upper deck plating but subject to renewed stringer plating over midship deep tank (P & S) and Fwd. engine room bulkhead in way to be tested prior to the completion of Special Survey, meantime tank top not to be subjected to pressure.
