WEAR & TEAR REPAIRS NOW EFFECTED:-

Approx. 90 scrubbed and wasted rivets in bilge strake of shell plating port and starboard cap welded.

CONDITION OF CLASS (S.R.L.No.250).

Corroded tank top margin bar rivets in way of Engine room (s.s.) repaired at this time, (included in wear and tear repairs to shell rivets above).

It is recommended that this Condition of Class be deleted.

The items now surveyed are detailed on this report. All were found or placed in good condition unless otherwise stated. I recommend, therefore, that this ship remain as classed with ~~without~~ fresh record of dry docking 4,66 without special condition in respect of tank top margin angle rivets in way of Engine Room, but subject to any other outstanding condition of class being dealt with as previously recommended.
