Dear Sir,

Having reference to your three letters of the 7th September relating to the verification of freeboard marking for twelve steamers, I have to state as follows:-

- ✓ Kanan Maru: Verification form enclosed herewith. ✓ ✓
- ✓ Kashin Maru: Verification form (dated 30th Oct. 1922) has been forwarded. ✓
- ✓ Kishu Maru: Assignment letter sent Hong Kong as the vessel was to be at that port from about 7th to the 17th instant.
- Seikyo Maru: Assignment letter sent Shanghai where the vessel was to be about the 10th instant.
- ✓ Chosa Maru: Verification form enclosed herewith. ✓ ✓
- ✓ Fukuken Maru: Assignment letter sent Shanghai where the vessel was to be about the 8th instant.
- ✓ Gifu Maru: The freeboard was verified on the 27th Oct. 1921 before the date of the assignment letter

but the forwarding of a verification form was apparently omitted. The form is now enclosed showing the marking in agreement with the assignment. ✓

✓ Iwate Maru: The freeboard was verified on the 27th December 1921 and a temporary freeboard certificate granted on the 13th January. A verification form does not appear to have been forwarded and one is now enclosed. ✓

✓ Tachibana Maru: Verification form forwarded 4th September 1922. ✓

✓ Yoro Maru: This is the S/S "Cheribon Maru" No. 56453 R.B. (Mitsubishi Dockyard No. 83). The verification form was sent on 1st April 1921. The name "Yoro Maru" was only provisionally given.

✓ Shinai Maru: (Fujinagata Dockyard No. 43). A freeboard of 5 ft. 6½ inches was provisionally marked and no opportunity has occurred for having it corrected but enquiries are being made and it is hoped that a verification form may soon be forwarded.

Seikai Maru: Arrangements are being made to have the freeboard verified at an early date.
