CASES OF 38 VESSELS OWNED BY MESSRS. KELSALL BROTHERS & BLECHING, LIMITED, and THE HULL STEAM FISHING & ICE CO. LTD.

At the end of March last letters were received from the Hull Steam Fishing & Ice Co. Ltd. and Messrs. Kelsall Brothers & Beeching, Ltd. intimating that the Directors had decided to withdraw all the vessels owned by the above companies from Lloyd's classification.

In reply to inquiry in regard to the matter, the Society's Surveyors at Hull stated that they understood the control of these companies was in the hands of Mr. John Slater, of Messrs. John Slater, Limited, London, and suggested that Mr. Slater should be communicated with.

On being interviewed Mr. Slater intimated that he would again place the matter before the Directors for their re-consideration, and he stated at the end of last month that the Directors had again considered the matter and that they had definitely decided to withdraw the classes of the vessels belonging to the above companies from the Register Book.

Subsequently a letter was received from the Hull Steam Fishing & Ice Co. Ltd. requesting that the classes of four of the vessels, viz:- "WITHERNSEA", "FLAMBOROUGH", "DOGGER BANK" and "WARTER PRIORY" should be retained in the Register Book.

The names of the vessels which are to be withdrawn from classification are given below.
