The following trawlers, registered in the names of the Hull Steam Fishing and Ice Company, Limited, and Messrs.Kelsall, Brothers and Beeching, Limited, are actually under the control of Messrs.John Slater, Limited, London, who have stated that they have definitely decided to withdraw the classes of the vessels from the Society's Register Book.

In the circumstances, the Classing Committee, who had the cases before them on Friday, 13th instant, decided to withdraw the character of each trawler from the Register Book and to insert three dots (...) in lieu thereof, indicating withdrawal of class at Owners' request.
