This trawler was last submitted for Special Survey 1939 and has since been in the service of the Ministry of War Transport from which she was released and returned to her Owners 11.45.

The HULL Surveyors report (4.46) ship examined on slipway, shell plating drilled with results as above and renewals to several shell plates recommended, but not yet dealt with.

It was stated that owing to the age of the ship and the amount of repairs necessary to put her back into condition for service, it has been decided to lay her up pending the decision of the Owners as to whether she should be repaired or sold. Nothing has been done towards repairs or Special Survey.


