Enclosed please find report form relating to the Engine Machinery of the above auxiliar Schooner, which report has been filled up by Mr. Pedro Cassou, Marine and Engineer Surveyor.

On sending us said report he wrote to us:

"In compliment to your request for to fill the sheets for particulars of Engines of the Mexican three masted Schooner "SAN RAMON" (ex "JAYO"), I enclose you the sheets filled with particulars given by the owner Mr. Manuel Angel Fernandez. Particulars for crank webs cannot be given until "return of Ship for to take measures on board".

"I have seen the Lloyd's Certificate and spare gear as I have mentioned "before in my previous report".

For your information we beg to send you herewith enclosed a copy of the Survey Report on said vessel rendered by Mr. Cassou last December and we trust it will be useful for your Committee.

We beg to apologize for our apparent neglect in answering your letters of the 7th. July and 6th. November, 1922 but as the vessel had not been surveyed Mr. Cassou could not fill up the form and afterwards he experienced some difficulties in obtaining data from the owners.

Inserted in said report you may find sizes of the shafts.

If any further information is required by your Committee on this vessel please let us know in order we may request Mr. Cassou to be pleased to furnish us with the information.

Allow us to seize this oportunity for begging from you to please send us two copies of LLOYD'S Rules and Regulations for construction of vessels as they stand presently, one copy for the use in this Agency and the other one to be presented to Mr. Cassou.
