The class of this vessel was withdrawn from the Register Book at the Owners' request in September 1925.

With a view to reclassification the Hull Surveyors report the vessel placed on a slipway and the requirements of 2nd S.S. No.3 partly complied with.

The shell plating has been drilled with results as shewn above which might be approved provided the recommendations now made be carried out to the Surveyors' satisfaction.
