The Four (4) Main Boilers were examined over all parts with doors, mountings and safety valves and found or now placed in good condition. Safety valves adjusted under steam as stated above.

The following engine parts, opened up by the Owners, examined as far as practicable and found in good order.

All cylinders, pistons, valves and rods, crank, thrust and intermediate shafting, air pumps, bilge pumps & centrifugal pumps.
