the undersigned Surveyor to this Society did at the request of the Shipbuilders, Messrs. The Blythswood Shipbuilding Co. Ltd., survey the Steel Screw Motor Vessel "LAUREL", 10014 tons Gross of Stockholm as she lay in Govan Drydock, Glasgow, on the 7th July 1930 and the 28th July 1930 to ascertain the nature and extent of the Damages: "A" stated to have been caused by vessel striking quay wall at entrance to Princes Dock on 7th June 1930 and "B" stated to have been caused by vessel again striking quay wall at Princes Dock during undocking on the 11th July, 1930.

On examination found and recommended as follows:-

"A" Damage.



Shell plate No. 19 - E. Strake port side set in.	No. 19 plate E. Strake to be renewed.
Shell plate No. 19 - F Strake port side set in.	No. 19 F. strake to be renewed.
Longitudinal on F. 19 set in.	Longitudinal to be removed, faired and replaced.

REMOVALS:- Riveting on adjacent plates to be cut out as necessary to effect repairs.

Nos. 2 & 3 Deep Oil Tanks to be tested on completion of repairs.

Transverse No. 67 to be cropped and part renewed and shell lugs to be renewed.

Longitudinal on F. 19 set in.

Longitudinal to be removed, faired and replaced.

REMOVALS:- Riveting on adjacent plates to be cut out as necessary to effect repairs.

Nos. 2 & 3 Deep Oil Tanks to be tested on completion of repairs.

All new and disturbed work to be cleaned and recoated as necessary.

The foregoing recommendations were made with a view to placing the vessel in as good and efficient condition as before the damage was sustained.
