

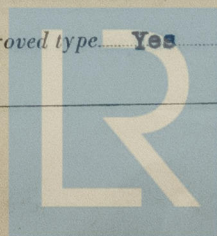

General Remarks (State quality of workmanship, opinions as to class, &c.)

Entire aft quarters and machinery spaces re-wired. Existing fixtures used in machinery spaces. All cable under fore and aft gangway from aft quarters to amidship accommodation renewed. All cable is varnished cambric insulated leaded with basket weave armor. Cable of 4110 circ. Mils and smaller is rubber insulated. The generator examined under full working condition, the reverse current and overload devices operated and found in order. In my opinion the electrical installation of this vessel is in good and safe working condition and meets the special requirements of vessels carrying petroleum with flash point less than 150° F.
