The items now surveyed are detailed on this report. All were found or placed in good condition unless otherwise stated. Ship examined afloat. All holds, superstructures, Engine and boiler room tunnel, weather decks, hatchways including securing arrangements, vents, casings, and windlass examined. Soundings taken from all double bottom tanks and showed no sign of leakages.
