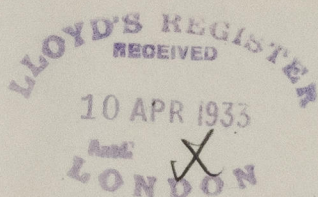

Dear Sir,

With reference to your letter of the 28th ultimo respecting the freeboard assignment in the case of the steamer "AUGSBURG" I have to advise you that the freeboards as indicated in your assignment letter of the 27th ultimo have now been approved by the See-Berufsgenossenschaft and arrangements will be made to have the freeboards marked on the vessel's sides by the representatives of that body.

The assignment letters forwarded with your letter and intended for the Owners and for the Bremen Office have today been sent on to the Bremen Surveyors with a request to arrange for the verification of the markings when placed on the ship's sides. The Bremen Surveyors have also been requested to forward to you the usual verification of marking form as soon as the freeboard markings on the ship's sides have been verified and found to be in order to enable the necessary entries to be made in the Society's Register Book.
