The Owners of the above T2 tanker have decided to send this tanker to Germany for jumboizing and they are considering the possibility of towing her there instead of letting her proceed under her own steam. The Owners through their Surveyor at Piraeus made enquiries with your Representative there as to whether the Committee would approve of the vessel leaving Piraeus in tow without dry-docking or passing any survey, having regard to the fact that she has been laid up at Piraeus for 2 years and all her surveys are now overdue. The Society's Surveyor at Piraeus advised the Owners that this is a matter on which the Head Office could give a ruling, indicating, however, that the Owners may obtain an interim seaworthiness certificate for the vessel to proceed to Germany but not in class since her surveys would be overdue.

As you are doubtless aware, the survey status of the vessel is as follows:-


