3046 tons gross of Maracaibo, for the purpose of ascertaining the nature and extent of the damage stated to have been caused by collision with S.S. "REAPER" on 5th February, 1945 in San Nicholas Harbour whilst on voyage from Maracaibo to Aruba, fully loaded.

On examining the vessel whilst afloat at the Lake Tanker Discharging Dock, San Nicholas Harbour on 8th February, 1945, the undersigned

Found

Forecastle, Port Side

Shell plate P.J. 2, set in 6", for 2'0" down from forecastle deck, full length of plate.

Port bulwark plate No. 2 from stem set in 6" for full length and depth of plate.

Port bulwark plate No. 3 from stem, set in 6" for 6'0" from forward lap.

Angle bar on bulwark plate, bent and distorted.

Two bulwark stanchions in way of No. 2 plate, buckled.

Nos. 1 and 2 port forecastle deck stringer plates set down 9" and buckled.

Recommended

P.J. 2 to be renewed.

Port bulwark plate No. 2 to be renewed.

Port bulwark plate No. 3 to be cropped and part renewed.

Approx 2h'0" of angle bar to be cropped and part renewed.

To be renewed.

Nos. 1 and 2 stringer plates to be cropped and part renewed for approximately a length of 17'0".

Found

Forecastle deck stringer angle buckled and distorted.

7 ship side frames in way of damage, buckled.

4 reverse frames buckled.

7 deck beams buckled.

7 deck beam knees bent.

Fore peak air and sounding pipe, broken.

Port forward mooring bits displaced.

Further recommended that all removals be replaced and where damaged in the course of the above repairs, repaired or renewed as necessary.

These recommendations made so as to place the vessel in the same good and efficient condition as before the damage was sustained.

These repairs have now been completed to my satisfaction.

Recommended

Approximately 20'0" of stringer angle bar to be cropped and renewed.

7 frames to be cropped and part renewed.

4 reverse frames to be cropped and part renewed.

7 deck beams to be cropped and part renewed.

7 knees to fair or renew as expedient.

Air and sounding pipe to renew.

To be removed, and resecured.
