Further to our letter of the 27th. June 1951, and your reply of the 14th. July last, regarding the classification of four tankers built or building at Cammell Laird & Co., we have pleasure to inform you, that at a further interview held today at the offices of Yacimientos Petroliferos Fiscales, we were informed of their decision to retain the classification also of the following additional vessels built or being built as follows:-

- "Islas Malvinas", "Islas Orcadas", Islas Georgias",
- "Director Madariaga", "La Plata", "San Lorenzo", and
- "Comodoro Rivadavia".

It is also the Owners intention to reclass the M.T. "San Jose", and we shall be advised in due course of the date the vessel is being drydocked, so that the Special Survey can be carried out with a view to reclassification.
