We are in receipt of your letter of 18th inst., with regard to Yka. Rpt. No.1330 concerning the above named vessel, and have to reply as follows:-

Copies of the approved structural plans, Nos. 4 & 5, of the Orlop deck now fitted, & the deep tanks, respectively, are attached hereto.

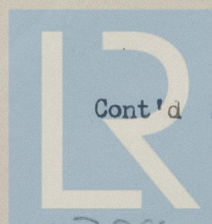
It is confirmed that:-

- (1) The present notation in the Register Book regarding the 4 divisional W.T. bulkheads in 'tween decks remains unaltered; and
- (2) The deck notation should now read " 2 decks, 3rd deck in No.1 hold".

(The third deck throughout the holds, shown on the pumping plan & termed 2nd deck therein, is really a misnomer. Actually this is a wooden platform erected temporarily in Nos. 3, 4 & 5 holds to be used during the fishing season only, & thereafter dismantled).

Also there was now bulkhead previously at frame 123, although this is erroneously shown in the pumping plan.
