Motorships "ITALSOLE" and "ITALVEGA"

Thank you for your letter of the 26th ultimo enclosing a copy of your reply to the owners of the above vessels regarding their decision to withdraw these ships from class.

Messrs. Italnavi have informed us that they wrote direct to Head Office in this case because they receive notices of surveys becoming due direct from London.

Messrs. Italnavi possess ships which are combined passenger and cargo ships as well as purely cargo vessels and they state that they intend to withdraw the class only of the cargo vessels. Some of these cargo ships are classed RI/AB and others RI/LR and Messrs. Italnavi inform us that they intend to retain only the R.I. class for their cargo vessels during the present recession.

Vessels classed with the A.B. will therefore also be withdrawn as special surveys become due.

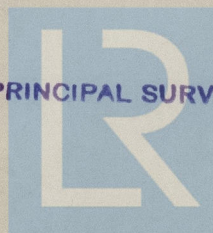
