Nippon Yusen Kaisha, survey the Twin Screw Steamer "HAKOZAKI MARU", 10413 tons gross, of Tokyo, on the 8th June, 1940, and subsequently whilst the ship lay afloat and in dry dock at Yokohama for the purpose of ascertaining the nature and extent of damages stated to have been caused at Liverpool (A) by ship hitting quay wall when entering Brocklebank Dock on 26th March, 1940 and (B) by ship being carried heavily against Princes Pier Landing Stage on 11th April, 1940.

Damage (A) All on Starboard side in way of side bunker hold.

Shell plate No.1 aft of midship on  
2nd strake below upper deck sheer  
strake part set in.

To be removed, faired  
and replaced.

Shell plate in way of midships on 2nd  
strake below upper deck sheer strake  
part slightly set in at after end.

To be faired in place.

2 main side frames, in way slightly  
set in.

Both to be part faired  
in place and one also  
part renewed.

2 deck beams at ends slightly buckled. To be faired in place.

2 Beam knees in way buckled.

To be removed, faired  
and replaced.

1 web plate, 1 beam knee and shell  
connection in way buckled.

Web plate to be cropped  
and part renewed,  
beam knee to be renewed  
and shell angle to be  
cropped, faired and  
replaced.

Shell repairs.

To be hose tested on  
completion.

Cement chocks in way.

To be renewed.

Valves and pipes with casings in way.

To be removed for access  
and replaced.

New and disturbed work.

To be recoated as formerly.

Damage (B) All on port side in way of Nos.4 and 5 Holds and  
Tween decks.

FOUNDRECOMMENDED

Shell plate No.7 from aft on 2nd  
strake below upper deck sheer  
strake part set in.

To be removed, faired  
and replaced.

Shell plate No.8 from aft on 3rd  
strake below upper deck sheer  
strake, part slightly set in.

To be faired in place.

Bulkhead wing plate and boundary  
angle in way set in.

Both to be faired in  
place.

Air pipes, scupper pipes,  
accommodation wood lining and  
Hold sparring in way.

To be removed for access  
as necessary and replaced  
on completion of repairs.

Cement chocks in way.

To be renewed.

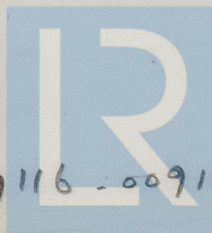
