The 2nd.S.S.No.2, due 4.26, has been partly held by the ranging of the chain cables and examination of the rigging.


Thirty fathoms of chain cable require to be placed on board and indented shell plating etc., dealt with at the Owners' convenience.

A proposal to postpone the completion of the survey has been agreed to provided it be carried out before the expiration of the year of grace.

The Falmouth Surveyors recently recommended that the furnaces of the starboard boiler be repaired before the vessel left that port and that the furnaces of the centre and port boilers be examined and those of the starboard boiler renewed within 6 months from the date of sailing.

The Surveyors, however, subsequently stated that the vessel had been towed to Hamburg where she was to be docked with a view to being sold.

The Bremen Surveyor now forwards a letter from the new Owner in which it is stated the vessel is now to be classed with the Germanischer Lloyd, and he has been informed by the Owner he does not intend to retain the class with this Society.
