Nature of Survey. Special Survey for Classification and Damage.

This vessel was built in 1945 and classed with the American Bureau of Shipping.

Classification with this Society is desired.

The vessel has the Notations 100A1 (Classification Contemplated), "Examined 12.46" assigned.

The tunnel W.T. door requires to be altered to comply with the Rules.

Plans for this type of vessel have been examined in this Office and found to be suitable for the class 100A-.

For full particulars of this case see previous endorsements.

The NEW YORK Surveyors, in a part First Entry Report to complete the New York Rpt. 1 No. 47606, and Rpt. 8, report 11.48 the vessel examined in dry dock and afloat, and the scantlings and arrangements to complete the First Entry Report, as above verified, and the requirements of a Special Survey for Classification complied with.

On account of two damages due to striking submerged object and heavy weather, repairs and renewals effected to a number of shell plates, floors, and other items.

Structural reinforcements, etc., as required for SAM ships, have been provided.

The equipment of anchors and chain cables complies with the Rules and has been tested by the Surveyors to the American Bureau. It is submitted the Figure '1' be assigned, but the Notation "Lloyd's A & CP" be omitted.

"The tunnel W.T. door to be altered to comply with the Rules at the first opportunity."
