

Steamers "SUNCLIFF" and "SUNFIELD".

A cheque has to-day been received from Messrs. Douglas & Grant for £100:14: 9 being the fees for the survey during construction of the machinery of the above vessels.

On the 30th January last the Leith Surveyors were advised in reply to enquiry that the fees due for the survey of the machinery of the s.s. "SUNCLIFF" were as follows:-

Of this amount, the amount to be credited to the Glasgow Office for the survey of the boilers was.....	£12: 3: 3*
and the amount to the Leith Office.....	36: 9: 9

In addition to these fees there was an amount chargeable in respect of the machinery as Standard machinery up to the time of transfer to private ownership, amounting to £15. Of this amount, the proportion to be credited to Glasgow was.....

Glasgow was.....	5: 1: 6*
and the proportion to the Leith Office.....	9: 18: 6
The expenses incurred at Leith amounted to....	1: 17: 0

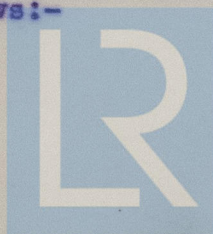
It will be seen from the above that the total amount due to the Glasgow Office was £17:4:9.

In the case of the "SUNFIELD" an account was rendered to Messrs. Douglas & Grant from this Office for £18, being the amount due for the survey of the machinery of this vessel up to the time of transfer to private ownership, of which.....

was due to the Glasgow Office and.....

to Leith.

The total amount due therefore for the two vessels, irrespective of the amount to be collected by the Leith Surveyors for the survey of the "SUNFIELD" is as follows:-



In view of the fact that Messrs. Douglas & Grant have remitted £100:4:9, it will be seen that they have over-remitted to the amount of £17:4:9, and it would appear that they have included the fee for the survey of the boilers at Glasgow, viz:-£17:4:9, twice over.

In these circumstances it is submitted that a cheque might be drawn for this amount and be forwarded to them with an explanation of the matter.
