COMPASSES.

Minimum distance between electric generators or motors and standard compass

Minimum distance between electric generators or motors and steering compass *about 138 feet.*

The nearest cables to the compasses are as follows:—

A cable carrying *2* Ampères *led into* feet from standard compass  feet from steering compass.

A cable carrying *1.5* Ampères *6* feet from standard compass  feet from steering compass.

A cable carrying ..... Ampères ..... feet from standard compass ..... feet from steering compass.

Have the compasses been adjusted with and without the electric installation at work at full power *yes*

Has the effect of switching on and off circuits, motors and other electro-magnetic apparatus within the vicinity of the compasses been noted *yes*

The maximum deviation due to electric currents was found to be *Nil* degrees on *any* course in the case of the
