EXAMINATION AND REPAIRS AS PER RULE FOR DAMAGE SURVEY AND PERMANENT REPAIRS AND ANNUAL SURVEY GENERAL EXAMINATION FOR POSTPONEMENT OF SPECIAL SURVEY UNTIL NOVEMBER 1958.

- 1. The vessel was reported to have sustained damage, stated due to contact with unknown vessel on the river Thames on 4th October, 1957 when on the voyage from London to Rotterdam.
2. Further on a damage was reported, stated due to contact with quay wall at Bremerhaven on 15th April, 1957.

Damage repairs now carried out: 1. PS sideplating-aft: found set in and dealt with as stated below:

- Plates numbered from forward: G-5,6 and 7, F4 and 5 renewed.
E-strake in way faired in place.
10 frames renewed, 4 frames faired in place.
Deckplating poopdeck aft: 4 plates renewed, 1 plate partly removed, faired and refitted.
PS stringer angle partly renewed.
4 Deckbeams partly removed, faired and refitted, 7 deckbeams faired in place.
Girder under poopdeck at centre-line partly removed, faired and replaced.
Railing on poopdeck repaired as found necessary.
3 sidescuttles PS in poopspace removed, repaired as necessary and replaced.
Side and deckplating hosed tested after repairs and found tight.

Corners of hatch No.2., Repairs of wooden hatchcovers, with have to be dealt with after arrival in German Port to which the vessel is proceeding now.

 Further found upon examination PS shellplates from forward: C-2 and D-3 set in, but in my opinion of no consequence for the present. This item has not been dealt with this time and may be marked as a blemish group "B".
 The outstanding items mentioned in S.R.L. has been specially examined, found satisfactory and may be carried out next Special Survey.

Found 22 deckbeams and 22 frames in hold cracked. Frames and deckbeams have been temporary repaired by electr. welding and fitting of welded rev. flat bars.
 One frame SB in FP space found cracked, and repaired by electr. welding.
 Rudder and rudderstock unshipped. Rudder repaired as found necessary, checked alignment of rudder and stock and both replaced on board in good working condition, after renewal of 2 rudder-pintles.
 Steering chains unshipped, annealed and examined and found satisfactory.
 Found pins of sheaves of steering gear satisfactory.
 Minor items of deckrepairs have been carried out.

General examination: See London letter dated 1-11-57.
 Examined FP and FP space, AP tank, hold and double bottom tank 1 SB and PS and single bottomplating in hold (ceiling lifted), Air and sounding pipes, general equipment decks, rudder and steering gear. Recommended repairs have been carried out with the exception of: renewal of entrance-hatchcover on FP space in forecastle.
 Repairs of hatchway-coaming corners of hatch No. 2.
 Repairs of wooden hatchcovers.

The vessel left our port without further notice and we have been informed by the old Owner that the vessel was sold to: new Owners: Witwe Gebina Lohmann and Bernhard Lohmann.
 New name: "BINA"
 Port of Registry: Haren a.d. Ems.
 Managers: Rederei J Schöning, Haren a.d. Ems.

With a view to the above I am of opinion that the vessel is in a good and efficient condition to proceed on her voyages, but it has ^{been} recommended the items concerning entrance hatch, hatchway corners and wooden hatchcovers to be dealt with after arrival in German port, to which the vessel is proceeding now, and further ~~to~~ the outstanding items at present attached to the vessel's class and the new item: Temporary repaired frames and deckbeams in hold to be dealt with as necessary at next Special Survey.
 If the items concerning entrance-hatch, hatchway corners and wooden hatchcovers have been dealt with, I am of the opinion that the general examination is completed to satisfaction and the postponement of Special Survey until November, 1958, may meet the approval of the Committee.
