"PIENINY", 8272 gross tons, of Gdynia, on 1st May, 1961, and subsequently, whilst vessel lay afloat and in dry dock at this Port, for the purpose of ascertaining the nature and extent of damage stated to have been sustained by the vessel due to a collision with the M.S. "ARTHUR MAERSK", which vessel was undocking from the No.1 dry dock of the Hongkong Whampoa Dock Co., Ltd., with the assistance of dockyard cranes, the "PIENINY" being moored to a dockyard buoy.

| 4) Forecastle bulwark plate, port side, set in and fractured. | To be cropped and part renewed and faired in place as necessary. |
| 5) Forecastle bulwark stay buckled. | To be removed, faired and refitted. |
| 6) Forecastle bulwark bracket connecting angle fractured at top. | To be removed, top portion to be renewed and angle refitted. |

| 8) | Forecastle three tier guard rails (port side) set in. | To be cropped and renewed or faired in place as necessary. |
| 9) | One length 3½" dia. buoy mooring wire fractured. | To be renewed. |

It was further recommended that all new and disturbed work be painted two coats approved quality and colour and that all repairs be satisfactorily tested as necessary on completion.

Repairs as recommended were carried out by the Hongkong & Whampoa Dock Co., Ltd., and the cost Hong Kong dollars Three Thousand Two Hundred & Eighty-Five only (HK\$3,285.00) is considered fair and reasonable.

Repairs commenced on 2nd May, and were completed, to the satisfaction of the undersigned, on 13th May, 1961.

The damage found is considered consistent with the cause alleged.
