

When we purchased the above vessel in May 1947, according to our records the following items were dealt with for Proposed Classification Purposes.

- ✓ Hull Examined in drydock.
- ✓ Fore Peak tank )
- ✓ Aft Peak tank ) were examined internally and
- Void tank (EV) ) tested by water pressure.
- cofferdam (EV) )
- ✓ Nos. 1, 2 and 3. deep tanks examined.
- No. 1 D.B. oil fuel tank ) tested by water pressure.
- No. 6 " oil fuel tank )
- ✓ Holds, tween decks, chain lockers, decks, hatch coamings, hatch hatch battens and hatch covers were specially examined.
- ✓ Windlass and steering gear opened up and specially examined.
- ✓ Auxiliary steering gear equipment checked.
- ✓ Tail shaft drawn and specially examined.
- ✓ Freeboard assigned and Certificate issued.
- ✓ The main engine and all the auxiliary machinery were opened up and specially examined.
- ✓ The boilers were opened up and specially examined.

It is our intention on the return of this vessel to the U.K. at the end of next month, to carry out the examination of the remaining items necessary for Classification purposes.

- ✓ Nos. 2, 3, and 4 and 5 D.B. tanks to be tested by water pressure.
- ✓ Rigging to be examined.

- Electrical installation to be examined.
- Blank flanging arrangements to deep tanks to be examined
- Bilge suction to deep tanks to be examined.
- Concurrently with this work Load Line and Boiler Survey to be dealt with.
