

Minimum distance between electric generators or motors and steering compass..... 72'0"

The nearest cables to the compasses are as follows:—

A cable carrying Ampères inside feet from standard compass 14'0" feet from steering compass.

A cable carrying Ampères 14' feet from standard compass inside feet from steering compass.

A cable carrying Ampères feet from standard compass feet from steering compass.

The maximum deviation due to electric currents was found to be Nil degrees on every course in the case of the standard compass, and Nil degrees on every course in the case of the steering compass.

General Remarks (State quality of workmanship, whether insulation tests, etc., have been made, opinions as to class, etc.)

The electrical installation as now seen appears, with minor alterations carried out in this country, to have been installed in Germany by the A.H.G. and in accordance with German practice.

The generators have been changed and two 15 K.W. (Makers Cambell & Isherwood) and new main switchboard fitted.

The generators, steering gear, lighting circuits etc. were tested under working conditions with satisfactory results and the insulation resistance of all circuits and apparatus measured and found good.

The installation appears to be efficient condition and whilst not strictly in accordance with the Society's Rules, is, in my opinion, eligible to be accepted for classification.
