I have surveyed the above ship in accordance with the Rules for Damage Survey stated sustained on the 25th May 1963 at Abidjan due to a log fallen on deck across No.2 hatch and on the 2nd-4th July 1963 at Marseilles due to a log fallen on the Double bottom No.2 (stbd) tank top, whilst handling logs cargo.

The items now surveyed are detailed on this report. All were found or placed in good condition unless otherwise stated. Upon examination it was found the longitudinal hatch coamings badly damaged and upper deck distorted in way downwards. Renewed No.2 hatch longitudinal coamings completely. Removed to workshop, faired and refitted the upper deck beams frames 115-117 on stbd. side and frames 114-110 portside. Removed, faired and refitted the beam knees of frames 110-122 port and stbd. Faired in place the upper deck between frame 110-122 port and stbd. Renewed one deck plating starboard side, adjacent to stringer plate between frames 113-118. Longitudinal hatch coaming stiffeners brackets and cleats now renewed. Hose tested satisfactorily the deck and coamings in way on completions of repairs. Bullwork port and stbd. abreast No.2 hatch satisfactorily renewed. New Item in the S.R.L.

"Double bottom No.2 tank top (starboard side, tests at frame 118-120 and floors in way indented (steel doubler refitted) to be specially examined and dealt with
