

Minimum distance between electric generators or motors and steering compass -

The nearest cables to the compasses are as follows:—

A cable carrying 25 Ampères inside feet from standard compass T feet from steering compass.

A cable carrying - Ampères - feet from standard compass - feet from steering compass.

A cable carrying - Ampères - feet from standard compass - feet from steering compass.

Have the compasses been adjusted with and without the electric installation at work at full power Yes

The maximum deviation due to electric currents was found to be Nil degrees on every course in the case of the standard compass, and - degrees on every course in the case of the steering compass.
