I have surveyed the above ship in accordance with the Rules for

DOCKING AND ANNUAL LOAD LINE SURVEY.

The items now surveyed are detailed on this report. All were found or placed in good condition unless otherwise stated.

REPAIRS. Wear and Tear. Shell plate D.3 (ps from a) found wasted locally in way of bilge pump sea suction, plate now cropped and part renewed with a welded insert.

Shell plate E.4 (ps from a) plate found scored and lightly indented with frame rivets scrubbed, plate now reinforced with a welded doubling.

The (f & a) bulkhead plating of the port side bunker found wasted locally at top corner, bulkhead plating now cropped and part renewed with a welded insert.

All parts of steering gear dismantled, cleaned and examined, the steering chains annealed.

Steering gear tried after assembly and found satisfactory.

I recommend that this ship remain as classed with/without fresh record of dry docking 11,62.

Where conditions of class are recommended to be retained, imposed, amended or deleted, particulars must be stated above and on the interim certificate.)
