"TELOK VI" 117 tons gross of Djakarta, on the 4th. of November 1960 and subsequently whilst in dry-dock and afloat at Djakarta, for the purpose of examining without prejudice alleged damage, stated to have been sustained on the 25th. of October 1959 in the Banka Straits, due to contact with the M.V. "TONG SING".

On examination the undersigned:-

RECOMMENDED

(Damage in way of soft nose stern plating and port and stbd. shell plating in way).

Shell plate (Cl(p.s., from forwd.), buckled at forwd. end.

Crop and forwd. section renew (approx. .75 metres).

D1 (forecastle sheer) (p.s., from forwd.), buckled at forwd. end.

Crop and forwd. section renew (approx. 1.5 metres).

Cl (s.s., from forwd.), distorted at forwd. end.

Release, fair and refit.

D1 (forecastle sheer) (s.s., from forwd.), buckled at forwd. end.

Crop and forwd. section renew (approx. 1.5 metres)

Upper section of soft nose stern plating set in/buckled.

Crop at 2.0 metre drt. mark and renew up to top of bulwark plating (incorporated in D strake).

CL wash bulkhead plating  
in forepeak tank in way of  
soft nose stern plating,  
distorted.

Release, fair and refit.

Freeboard deck plating (fore  
peak tank top) set down in  
way of soft nose stern.

Crop and forwd. section renew  
(approx. ,75 metres long)

Two forwd. side frames  
(one port, one stbd.) in  
forepeak store, buckled  
together with their deck brackets,  
beam knees and deck beam.

Both frames renew .  
Both deck brackets renew.  
Both beam knees renew.  
Deck beam renew.

Both breast hooks in forepeak  
store buckled.

Both breasthooks renew.

Vertical stiffener on soft nose  
stern plating in fore peak  
store, buckled.

Renew.

Forepeak tank airpipe and goose-  
neck buckled.

Airpipe completely renew.

Forecastle deck plating buckled  
in way of soft nose stern  
plating.

Crop and forwd. section renew  
( approx. 1 metre long).

Forecastle bulwark/soft nose  
stern plating horizontal  
bracket, buckled.

Bracket renew.

Forecastle bulwark rail bar  
buckled( p & s) at forwd. ends.

Rail bar crop (p & s) and  
forwd. sections renew (approx.  
one metre each side).

GENERAL

Repairs to be water tested on completion.

All material, fittings, etc: disturbed in effecting repairs to  
be put back in similar condition to that before the alleged  
damage was sustained.

All new and disturbed fittings effected by repairs to be suitably  
coated.

The foregoing repairs and work incidental thereto, have been  
carried out so as to place the vessel in the same efficient  
condition as that before the alleged damage was sustained.
