the undersigned Surveyor to this Society did at the request of the Owners attend on board the Steel Screw Steamer "KOSTRENA" 523 tons gross of Rijeka, on the 2nd February 1956 and subsequently, while vessel lay in floating dock at Trogir, for the purpose of ascertaining the nature and extent of damage alleged sustained on the 28th January 1956 through striking with her stern a rock while manoeuvring in the port of Trstenik.

After sighting the ship's Log Book and upon examination of the vessel in floating dock, following was found and preliminary recommendations were made without prejudice to the terms and conditions of insurance.



As the Owners made arrangements for the vessel to be towed to Rijeka where the necessary repairs should be carried out, it was recommended that she be further examined and recommendations made, as found necessary, after removal of the above mentioned damaged parts.

The foregoing recommendations were made with a view to placing the hull and machinery in the same good and efficient condition as before the alleged casualty occurred.
