With regard to the "KERALA", the Calcutta Surveyors state that the Owners have not yet come to any decision relative to the Screw Shaft Survey.

In the case of the "LORD WILLINGDON", the Calcutta Surveyors forward a letter received from the Owners intimating that the screw shafts were withdrawn about two months' ago. The Owners ask whether in view of this recent withdrawal of the shafts it will be possible to postpone the survey until the vessel is again drydocked in six months' time. The Owners point out that as the vessel is a suction dredger working with a pipeline her propelling engines are very seldom in use and that the distance she will travel in the next six months will not in all probability exceed ten miles. In connexion with this case the Calcutta Surveyors write:-

"In view of the travelling time necessary to carry out these smaller surveys in the Madras district (i.e., five to six days according to which part of the coast the vessel is working) it is submitted that a competent Consulting Engineer in Madras be appointed to act on our behalf, and that we should only attend at the Special Surveys. The travelling expenses for the minor surveys (approximately £30/-) are out of proportion to the P.T.O.
