The electric generating set with this vessel is only an 8 k.w. set, and it would appear that you have included in your fees, the electric generating set supplied by Messrs. Merryweather, which latter set has nothing whatever to do with the electrical installation on board the ship, and was separately surveyed to meet Owners requirements alone, by the Surveyors in London, which certificate - dated 16th July - we already hold.

We are satisfied you are under some misapprehension regarding this, and have taken it that the two sets are both concerned with the electrical installation on board the ship.
