We have surveyed the above ship in accordance with the Rules for Periodical Docking Survey, Annual Survey, Repairs, Commencement of Special Survey and General Examination for Postponement of Completion Date of Special Survey.

The items now surveyed are detailed on this report. All were found or placed in good condition unless otherwise stated.
Repairs (Wear & Tear) :-

Rudder lifted and new top pintle made and fitted. Steel liner made and welded into bottom gudgeon and old pintle machined to suit. Top and bottom lignum vitae bushes renewed. Shell plates F.8 & 9 (s.s.a.) and F.15, G.14 & H.14 (p.s.a.) were all found to be indented at this time. The Owners' representative requested that the repair of these items be dealt with at the Special Survey. The indents were tested and found tight and it is therefore recommended that the

We recommend that this ship remain as classed with/without fresh record of dry docking 3,63, and have the notation of S.S. (with date) upon completion, subject to indented shell plates F.8 & 9 (s.s.a.) and F.15, G.14 & H.14 (p.s.a.) all being specially examined and dealt with as necessary by completion of the Special Survey.

repair of these items be deferred meantime, but that they be specially examined and dealt with as necessary by completion of the Special Survey.

S.R.L. Items :-

(1) Corroded keel plating except No.2 to be specially examined and dealt and as necessary at the next drydocking. Keel plate chipped over its entire length at this time and specially examined. Keel plate No.13 from aft was cropped and renewed over twelve frame spaces and No.1 from aft and forward effectively doubled. The remainder of the keel plating was found to be satisfactory although many rivet heads were badly corroded. 1,300 rivets renewed. The whole tested upon completion and found sound and tight. It is recommended that this condition may now be deleted.

S.R.L. Appendix :-

Keel plates No.3 & 4 from aft indented - examined and found to continue efficient meantime.

General Examination :-

This vessel generally examined at this time in accordance with Circ. No.1959 and as detailed elsewhere and the condition of the vessel so found or now placed is such as in our opinion warrants favourable consideration being given to the request for postponement of completion date of Special Survey for a period not exceeding twelve months from the due date.


