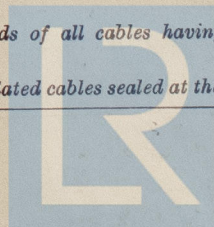

Minimum distance between electric generators or motors and standard compass *40 ft*

Minimum distance between electric generators or motors and steering compass *35 ft*

The nearest cables to the compasses are as follows:—

A cable carrying *2* Ampères *inside* feet from standard compass *5* feet from steering compass.

A cable carrying *1* Ampères *5* feet from standard compass *inside* feet from steering compass.

A cable carrying Ampères feet from standard compass feet from steering compass.

Have the compasses been adjusted with and without the electric installation at work at full power *Yes*

Has the effect of switching on and off circuits, motors and other electro-magnetic apparatus within the vicinity of the compasses been noted *Yes*

The maximum deviation due to electric currents was found to be *nil* degrees on *every* course in the case of the standard compass, and *nil* degrees on *every* course in the case of the steering compass.
