The vessel was placed on slipway at this port on account of damage which stated to have been sustained due to grounding near to the New Waterway entrance, in January last.

Found : Propeller and screwshaft heavily damaged.
The bottom plating of the engine room damaged to such an extent that removal of the main engine will be necessary in order to carry out the ship repairs.
Recommendations for engine repairs are subjected to further examination of the machinery installation, which was not requested by the Owners.

The vessel has now been sold and towed to the Port of Amsterdam for repairs.
