The items now surveyed are detailed on this report. All were found or placed in good condition unless otherwise stated.

Repairs for damage, the causes of which were not stated:Found:

Keel plates No.1 &amp; 2 from aft set up in way of aft buoyancy space and No.2 Port &amp; Starboard tanks. Starboard forward corner plate set in, in way of forward buoyancy space.

Starboard sheerstrake No.1 plate from forward indented and deck plate in way buckled locally.

Starboard sheerstrake 3rd plate from forward indented.

Now Done:

Keel plates No.1 &amp; 2 from aft renewed. Aft buoyancy space and No.2 Port &amp; Starboard tanks satisfactorily pressure tested on completion.
