EXAMINATION AND REPAIRS AS PER RULE FOR Repair of damage stated to have been caused through navigation under heavy weather whilst on voyage from Portland to Osaka on the 18th January to 19th Feb., 1958.

Now Done: Attended on board at Osaka Port on the 20th February, 1958 and subsequently, the permanent repairs of damage have now been carried out as recommended.

### Damage:

4 starb'd bulwark stays abreast windlass faired in place and rewelded heel attachment.

Weather deck plate in front of windlass faired in place, one pillar under deck removed, faired and refitted.

No.3 hatch side weather deck plate port side fractured in way of butt weld & now veed out rewelded and newly fitted butt strapped by welding.

Hatch coaming angle removed partly and refitted.

Galley casing plate starb'd fractured and now welded and newly fitted doubler.

Bulwark top rail fractured abreast No.3 hatch starb'd and now welded.

3 side scuttle glasses now renewed in living rooms.

Engine skylight stanchion refitted by welding.
