One shell plate in way of belting holed - belting removed and plating doubled and belting refitted.

Hose tested on completion and found satisfactory.

Steering gear, sheaves, pins overhauled as found necessary.

Steering gear chains annealed & examined.

Sundry minor repairs.

I recommend that this ship remain as classed with ~~SS(M)~~ fresh record of dry docking D.S. 6,63 and the notation of SS(M)6,63 for twelve months.
