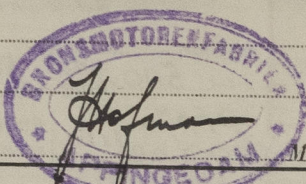

The engine will be shipped to Heusden (Rotterdam District)
