**This is to Certify** *that I have surveyed part of the machinery of the S/S "WINAMAC" 11981 gross tons of Panama for Tailshaft Survey Continuous Liner, Main Boiler Survey and Continuous Survey of Machinery whilst the ship lay afloat and in dry dock at Bremerhaven on the 4th September, 1964 and subsequently and that all my recommendations have been carried out to my satisfaction. I am reporting accordingly and recommending to the Committee of Lloyd's Register of Shipping that the machinery classification should be retained and the following survey records assigned* TS(CL) 9/64, MBS 9/64, CSM (with date) upon completion, subject to any outstanding condition of Class being dealt with as previously recommended.

Propeller and outside fastenings of sea connections.  
Port and starboard main boiler.  
Port and starboard main boiler safety valves adjusted.  
Sea connections.  
Port inboard aux. turbo generator engine.  
Stbd. steering gear pump.  
Emergency fire pump (in steering gear flat).  
Forward outboard feed water pump.  
Inboard main lub. oil pump.  
Starboard main condensate pump.  
Turbo driven fuel oil transfer pump (in forwd. pp. room)  
Fire and ballast pp. (in fwd. pump room)
