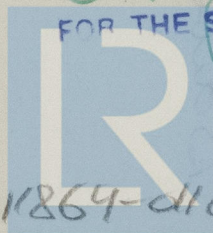
We are in receipt of a letter from the Owners' Representatives informing us that the Owners have decided to withdraw the Vessel's Class with our Society for reasons of economy.
