I have surveyed the above ship in accordance with the Rules for  
 & Periodical Load Line Survey.

Docking Survey, Alterations

The items now surveyed are detailed on this report. All were found or placed in good condition unless otherwise stated.

Wear & Tear Repairs

Approx. 100 scattered rivets in way of the No.1 keel plate and the  
 s.s. bilge strake found scuffed now cap welded and found satisfactory.

Alterations.

The lower tween decks in Nos.1,2 & 3 holds were at this time removed  
 as per the Secretary's letter dated 13.3.63 ref. ship.

In the No.1 & 2 hold the deck and deck beams were cut at the toes  
 of the shell frames and along bulkheads on frames 112 and 137, and  
 along centre line bulkheads leaving part of the deck & knees between  
 frames and stiffeners.

In No.3 hold the deck and beams were cut at the toes of the shell  
 frames but was cut at 1 frame space from the aft bulkhead and the  
 existing deck beam <sup>used</sup> as a stiffener.

The port and stbd. aft corners of the deck were so cut as to leave  
 a bracket attachment to the shell frames.

In way of the settling x tanks the deck plating was cut to leave  
 P.T.O.

I recommend that this ship remain as classed with ~~without~~ fresh record of dry docking DS 4,63  
 now, without special condition regarding the beam knee riveted  
 connection on floors 88/89 s.s. in way of the boiler room.

a stringer 2'-6" wide all round and the remaining part of the centre line division was cut at the toes of the stiffeners.

The pillars(10 in No.)  $\frac{1}{2}$  of the 3rd decks and the lower holds were found to be geometrically off set fore and aft. The part of the girder in way was therefore retained and conical closing plates manufactured and fitted, each approx. 1 meter in length, by electric welding.

On completion all the above alterations were examined and found satisfactory.

SRL No.199

Beam knee riveted connections in frames 88/89 s.s.in way of boiler room now re-rvted and found satisfactory.

It is submitted that this item be now deleted from the vessel's class.
