This Trawler was built at Beverley in 4,40 and then classed *100A- "Stm Trawler" "For Government Service".

She was converted into a Motor Trawler for fishing purposes at Southampton between 9/47 and 3/51 (refer Sou.Rpt. No.20616) in accordance with approved plans and the requirements of a SPECIAL SURVEY (C) were commenced by the testing of the oil fuel and fresh watertanks.

The ship has been laid up since 3,51 - refer also to Endorsement dated 2.4.51. She has now been towed to Hull where a complete Special Survey is to be carried out.

The HULL Surveyors report (1,55), this Trawler examined in dry dock, bottom coated and the requirements of a RECLASSIFICATION SPECIAL SURVEY complied with also minor wear and tear repairs effected.

The scantlings and arrangements as reported on the First Entry Report now forwarded by the Hull Surveyors have been checked with the original First Entry Report No.50672, together with the plans approved for conversion of ship into a Motor Trawler and conform with the Society's Revised Rules and Regulations and are in accordance with or equivalent to those shown on the approved plans.

The ship has 135 fathoms of 1.1/8" dia. chain cable on board (Rule requirements 135 fathoms 1.3/16" dia.) and 2 bower anchors, the collective weight 28½ cwts (Rule collective weight 18 cwts.).

It is considered the equipment might be accepted for the Figure '1' in this instance, in view of the excess weight of the bower anchors over Rule requirements (10½ cwts.) but without Lloyd's A & CP.
