We have to add that we were not requested to hold any Statutory surveys in this case as the original Tonnage Certificate, Loadline Certificate, Safety Equipment Certificate and Safety Radio Certificates were endorsed by the Panamanian Consul at Palermo, however, we are setting down hereunder, for your further information, the contents of the Secretary's cablegram of 18th March in this respect.


